



2023 FOOD VENDOR CONTRACT

DATE & LOCATION: June 22 – June 25, 2023 • Morrow County Fairgrounds – 195 S Main St – Mt Gilead, Ohio

SET UP: Between 6 am and 4 pm June 20-21. Between 6am and 10 am June 22.

TEAR DOWN: Between 6 am and midnight on June 26, 2023

VENDOR FEE: Flat Rate, ALL DAYS- \$1200 (4 days at \$300/day.) through January 1, 2023 **(MUST BE PAID IN FULL).**
After January 1, 2023 price will be \$1400 (4 days at \$350/day). Must pay \$300 deposit by December 1, 2022.

The number of food vendors will be limited by their menu. Applications will be reviewed as received and accepted or rejected on first come first served basis. **Full payment must be received to reserve food truck location.** This contract must be signed and returned by **June 1, 2023. All prepackaged drinks must be purchased through Finley's Entertainment LLC.**

2023 FOOD VENDOR RULES

VENDOR hereby contracts with Finley's Entertainment, LLC for space at the Freedom Fest Ohio as follows:

1. VENDOR agrees to use and pay for food booth space as described. VENDOR agrees to accept space assigned and will not sub-let to anyone else.
2. Neither the Finley's Entertainment, LLC, the Freedom Fest Ohio Committee will be responsible for any injury which may arise to VENDOR, their employees, agents, guests, or customers; or for the loss, theft of or damage to any food, display, merchandise, samples, or vehicle from any cause whatsoever while in transit to or from, or while participating in the Freedom Fest Ohio. By executing this contract, VENDOR agrees absolutely and irrevocably to waive and release any claim it may have against the Finley's Entertainment, LLC, the Freedom Fest Ohio Committee, their officers, officials, agents, or employees.
3. When ACTS OF GOD or any other causes not within the control of the Finley's Entertainment, LLC, the Freedom Fest Ohio Committee make it impossible for the VENDOR to occupy the Festival premises, then in such case the Finley Entertainment, LLC, the Freedom Fest Ohio Committee, their officers, officials, agents or employees are jointly released from any and all claims for damages which may arise as a consequence thereof.
4. The VENDOR also agrees to the following conditions of this contract:
 - a. Set up shall be completed between *6 am and 10 am* on June 22,2023.
 - b. Power will be provided with either a single phase 30-amp or 50-amp plug.
 - c. Only food specified in contract may be sold.
 - d. Booth sharing by VENDORS is **not** permitted.
 - e. The VENDOR agrees to always use qualified labor.
 - f. The management shall be entitled to close an exhibit at any time for failure of VENDOR to perform, observe and comply with any term set forth in the contract.
 - g. VENDOR shall not be entitled to a refund, or any part of any fee should he/she, for any reason, is unable to participate after acceptance.
 - h. If for any reason the management determines that the location of the Food Vendors should be changed or dates should be changed, management reserves this right.
 - i. All pertinent laws, ordinances and regulations pertaining to health and public safety shall be strictly observed.
 - j. Food VENDORS shall have appropriate license, insurance, and local health department permit.
 - k. VENDOR will cooperate by keeping Food Vendor area clean.
 - l. Exhibits left over-night are at the VENDORS own risk.
 - m. The number of food vendors will be limited by their menu. Applications will be reviewed as received and accepted or rejected on first come first served basis.
5. Professionalism and respect will be upheld at the upmost level and Finley's Entertainment, LLC **WILL NOT** tolerate unprofessional, rude, poor behavior, and disrespect toward its staff, patrons, or other vendors. Finley's Entertainment, LLC retains the right to remove anyone from the event without warning.
